1. Information about the public telecommunications services constituting the licensed activity and for which the license was issued:
  - data transmission services, telephony service via IP-protocol;
  - broadcasting of TV programs;
  - fixed satellite telecommunication services.
  
2. Specific License Terms and Conditions:
  - 2.1. the Licensee has the right to provide data transmission services using telecommunications facilities without using their functionality to provide IP-TV service;
  - 2.2. excluded;
  - 2.3. the Licensee has the right to provide services of satellite broadcasting of TV programs using an artificial satellite of the National System of Satellite Communication and Broadcast;
  - 2.4. the Licensee has the right to provide fixed satellite telecommunication services for receiving, processing, storing and transmitting telecommunication messages using telecommunication facilities that provide the ability to establish communication between earth stations with a given fixed location;
  - 2.5. the Licensee has the right to provide public telecommunications services using radio-electronic facilities of the fixed satellite service of the National System of Satellite Communication and Broadcast;
  - 2.6. the Licensee must comply with the decisions of the authorized body on the allocation of radio frequency bands, radio frequency channels or radio frequencies.
  
3. The Licensee is required to begin providing public telecommunications services listed above no later than 12 months from the date of the decision of the licensing authority to issue this license.
